She had long lived in Manhattan but joined the chapter in her Phelps family ancestral town of Simsbury, Conn, the Abigail Phelps Chapter #1002.

The DAR means this to be small ceremony, and so it was, with a reading of the DAR "Grave Marker" dedications. So, on Tuesday, October 23, 2012, about 110 years late, I and my sister, her namesake, proudly honored our great-great grandmother for her DAR membership with a permanent bronze DAR medallion on her marble crypt.

Melissa Phelps married William Earl Dodge in New York City, New York 1828 24 June, at the age of 19, at the home of her parents Anson Greene & Olivia Eggleston Phelps, 32 Cliff Street. They were close friends of his parents, David Low and Sarah Cleveland Dodge. This marriage connected the two families who went into business together, became the international behemoth, the Phelps-Dodge Corporation [copper and metals].

William Earl Dodge was a great Philanthropst in New York and helped to start the Young Men's Christian Association. YMCA. His statue stands outside the New York Public Library.

The View From My Window



I will start with something that is rather important. We are going to go to 4 journals a year instead of the 6 that we have been producing for years now. Part of the reason is the cost of postage and printing to those who still get it via the U.S. Postal Service. The other reason is that it takes a huge amount of time and energy, and just having had a birthday, and as my 7 yr. old great grandsons wrote in a card he made me "Happy Birthday Grandma Dodge, 80 something", I really want to have a little more time to do other things.

I will still be fostering for Safe Harbor Lab Rescue, but right now am taking a break from that. My dog, Polly, has been what I would call 'sick'. She is finally back to normal, but about 4 months ago, it was obvious something was very wrong, as she started to chew

the frames from around doors, any cartons she found around the house, bookshelves, and even tried chewing her way through the front door which is a thick wood door. As you can see from the photos, she did quite a lot of damage.

She would keep me up at night whimpering, pacing, going out of my bedroom to find something else to destroy. She would get up on any couch I was sitting on and try to get in my lap. One night, my daughter, Barb Jr. came over to spend the night and take care of Polly so that I could get some sleep. She was up all night. Polly would not leave her alone. She finally took Polly out in her car abt. 4 AM and drove and drove and Polly was quiet all during that time, but as soon as Barb brought her back, she started in with the same frantic behavior.

She quit eating and weight started to drop. Her eyes were wild, and I finally realized she had to be in great pain. I took her to my vet, and told him that I was quite sure it was her ears. She had been prone to have hematomas on the inside and outside of her ears, but this

time, I was sure it was a very deep ear infection. The Dr. checked her over and could find nothing else wrong, so he agreed with me that it might be her ears. He has a great ointment that has been developed that is a combination of 3 things and it goes deep in the ear with a syringe.* She had been shaking her head quite a lot, and almost as soon as he put this in her ears, she stopped that, stopped her whimpering, stopped her pacing, and chewing. That lasted for abt. 5-6 days, and then she started in again, but no where near as severe. However, 2 weeks later her behavior was escalating somewhat, so I took her in again, and she had another dose of that ointment in her ears. By this time, she had some learned behavior so she was put on TraZODone, PROZAC, and a Sedative. She was to have the TraZODone and Prozac twice a day and the sedative if needed.

Well...it seemed she needed it all but while it helped some, there still was some of the pacing and whimpering. I watched her carefully to see what might cause this and realized that whenever she had the Prozac, she started that behavior to some degree, so over a few days, I took away all Prozac. Then I noticed, that if I gave her a sedative at night, it seemed to do the opposite from what it was supposed to do. I found myself stroking her for up to 45 minutes before she would finally drop to the floor asleep.

I took away the sedative, and lo and behold, from that time on, she was a different dog & back to her old self.

In the meantime, though, I was determined to not let her starve to death. (I had a collie who did starve to death because she could not keep anything down and the vet I was using for her could not find anything wrong. I do not use that vet anymore!) Because Polly refused to eat, she was dropping up to 3 lbs in a week, I started to hand feed her, which meant taking the food in my hand, opening her mouth, dropping in the food, and then holding her mouth shut so she would have to swallow. It took quite a bit of time and it was like feeding a baby...when you end up with food all over you, the floor and the baby...but at least she was getting some nourishment. She went from abt. 76 lbs. down to 61 lbs. and at that point I

started to force feed her 4 times a day.

Every time I fed her, I had to start with hand feeding, and then suddenly after a couple of weeks, she actually licked her lips when she saw me getting her food ready, so I put her dish down and she sniffed and then stared at me. I turned my back and she started to eat.

As for getting her food ready, I bought Blue Buffalo canned dog food and mixed it into her dry food and put on some warm water. I did this for over a month, and then I found a new dog food product made by NATURE'S RECIPE...(and I really like their dog food. I used to feed my Frostie Collie their Salmon & Sweet Potato grain free)...called PURE ESSENTIALS. It is a limited ingredient dog food of salmon, brown rice, carrot, cranberry, pea, apple and flaxseed. Right now, and I believe until sometime in March it is on sale, \$41 for 24 pounds. It will go up, I am sure, to over \$50 just like all the other premium dog foods. Roscoe gets Blue Buffalo and that is abt. \$54 for 30 lbs., so I plan to get several bags before the price soars.

Polly has now gained most of her lost weight back, and finally has energy so that she can actually enjoy walking and I have even seen her playing with Roscoe a few times.

Obviously, that illness took a lot of my attention and energy, but it was worth it, because now instead of having to put Polly down (as I thought might be necessary) I still have her as a loving companion to both myself and Roscoe dog.


ON THE ROAD AGAIN

I will be visiting only the north east as that is where my ancestors spent their lives. But for those who live in the south, Midwest, north, or other areas, try to use the same tips I will be using in the areas where your ancestors roamed. So here we go.....a little taste of some of the places we will visit.

Cuba, MO – See the **World's Largest Rocking Chair** on Old Route 66. Bill's brother & his wife will be traveling along with us in their car as far as New York as they want to drive the old Route 66 and then we'll both go our separate ways, they to visit car museums and family in Iowa and us to search for ancestors in the east.


Granby, CT – Visit the **Nathaniel Holcombe House** (1648-1740).



Hop Meadow: Forefather's Burying Ground

Hartford, CT – **George Denison, Sr. graveyard** – **Old Center Church in Hartford**, wife Ann in Elm Grove Cemetery in Mystic, and tour his home, **Pequotsepos Manor**, also in Mystic.

Windsor, Simsbury (now Canton), CT – Since this area was largely founded and settled by my ancestors, I need to walk

the ground they walked. We'll visit the Congregational Church in Windsor, and the Old cemetery to find the grave of John Owen (1622-1698). Thomas Barber built the first church in 1683 and the first gristmill, now a restaurant which was restored in 1985, called the Hop Brook Restaurant (got to have dinner there!). See the cemetery where Samuel Barber's


wife, Tryphena, has the oldest grave monument there. I believe East Granby is nearby where Elijah Owen (1706-1741) and his wife Hannah Higley (1717-1806) Owen Mills settled in Turkey Hills, now East Granby. It is said their farm is still pointed out to tourists. We'll visit the Simsbury Newgate historic copper mine, Higley Town, and grave of Capt. Higley in Hop Meadow Burying Ground.

Beverly, MA – Gravestones in old graveyard of Nicholas (1618-1686) and Anna Palgrave (1626-1701) Woodbury. Lots of Dodge family history here too as you all know.

Chelmsford, MA – Samuel Adams built the first mill here. With over 200 descendants of Henry Adams, "Father of the Presidents", who were born and died here, this will be a very rich area for Bill and I as we both descend from Henry Adams. We'll visit the Forefather's Burying Ground.

Haverhill, MA – Visit Whittier Homestead, home of Thomas Whittier (1620-1696), on the bank of East Meadow Brook in the East Parrish of Haverhill.

Hingham, MA – Visit the Old Pentucket Burial Ground in Haverhill, MA where John (1614-1687) and Mary Marsh (1622-1697) Page are buried, see 'Page Bridge' and 'Page Meadow' and check out the History of Hingham and Haverhill for more about John Page.

Topsfield, MA – Visit the historical homestead site of William (1598-1673) & Joanna Blessing Towne (1598-1682) and walk on the **Towne/Treadwell Walking Path**.

Tyngsboro, MA - Try to find the ancestry of my gr gr grandmother, Mary Ann McMellen/Warren/Wyman (1823-1894) who was adopted. Her family is descended from a son of the Tyng's who founded Tyngsboro. Her history fascinates me and I hope I can find more about her.






Recently, while going through papers that belonged to my husband, Earl F. Dodge, who died in 2007, I found the following copy of a letter. I do not know from whence he got this letter, but it had to have been mailed to him from some member of DFA many years ago. The letter is a retype of what is supposedly the original. I have retyped it from the paper I found, and neither inserted, not took out any punctuation. The General Dodge House in Council Bluffs receive a copy of each of our Journals and we may hear from them as to the veracity of this letter. If we do hear from them, we will include it in our next journal.

LETTER from GEN. GRENVILLE M. DODGE to Gen. W. T. Sherman DATED June 8, 1868

Dear General -

I intend to go West about the 15th and may not see you this month. I am anxious that you should at a proper time and way come out for Grant by letter or in some way that it will be fully understood. It will have great weight and will be potent with many. I am very anxious that Grant should be elected—probably more anxious than he is himself, it of course comes partly from a personal love of him; but I fully believe his elections as President will bring quiet peace, and stability to our country, the same—that his promotion to command our Armies brought victory to our arms and ended the war.



June 9 1868

Dear General -

I intend to go West about the 15th and may not see you this month. I am anxious that you should at a proper time and way come out for Grant by letter or in some way that it will be fully understood. It will have great weight and will be potent with many. I am very anxious that Grant should be elected - probably more anxious than he is himself, it of course comes partly from a personal love of him; but I fully believe his election as President will bring quiet peace, and stability to our country, the same - that his promotion to command our Armies brought victory to our arms and ended the war.

It is honest, straight forward - and meets all the questions to be presented in a fair, open spirit. We are all well.
